In compliance with Title 17, Chapter 36, Section 15, *Utah Code*, which states:

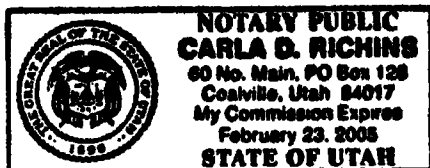
